Extension of Conditional Movement Control Order (CMCO) for Selangor, Kuala Lumpur and Sabah

Members are advised that YB Datuk Seri Ismail Sabri Yaakob, Senior Minister of Defence, announced on 5th December 2020 that the National Security Council (MKN) has decided to extend the implementation of CMCO in the states of Selangor, Sabah and Federal Territory of Kuala Lumpur to 20th December 2020. However, Sabak Bernam, Hulu Selangor, and Kuala Selangor districts in the state of Selangor are no longer under CMCO with effect from 7th December 2020.

- **2.** (a) With the announcement by YB Datuk Seri Ismail Sabri Yaakob as stated in paragraph 1 above, all the states (excluding the areas as listed under para 2(b) below) in Malaysia except Selangor, Sabah and Federal Territory of Kuala Lumpur are no longer under CMCO and placed back under Recovery Movement Control Order (RMCO) until 31st December 2020.
- (b) Areas still placed under CMCO until 20th December 2020 are as follows:

- **3.** YB Datuk Seri Ismail Sabri Yaakob also announced that with effect from 7th December 2020, activities allowed in CMCO areas are as follows:
 - (a) Inter-district and interstate travel except entering and leaving areas under Enhanced Movement Control Order (EMCO);
 - (b) The passenger limit in a vehicle is based on seat capacity (no longer limited to 2 persons in a car);
 - (c) Movement into and out of Sabah is allowed subject to negative result for RT-PCR or RTK Antigen test which is compulsory to be conducted three (3) days before travelling;
 - (d) Face to face meetings at hotels are allowed with social distancing and subject to 50% of the original maximum capacity;
 - (e) Use of swimming pool at hotels is allowed with social distancing;
 - (f) Dine-in is allowed without limit but with social distancing;
 - (g) Business activity is allowed to operate until 12.00 midnight;
 - (h) Filming activity is allowed without spectator and subject to minimum crew;
 - (i) Live event without spectator is allowed;
 - (j) Indoor busking is allowed subject to number of spectators to be determined by Ministry of Communication and Multi Media;
 - (k) All business activities under cultural and tourism sector are allowed except:
 - (i) Theme park, cinema and indoor playground;
 - (ii) Meeting, seminar, workshop, training, courses, conference, lectures, and exhibition;
 - (iii) Official and unofficial ceremony of the government and private social activities
 - (iv) Art and craft product exhibition, museum, library and art gallery;
 - (v) Tour and travel in and out of the country.



4. Please be informed that upon checking with MKN, MEF was informed that the industries registered with MITI in areas under CMCO are still obliged to implement work from home (WFH) for employees in the management and supervisory categories under which only 10 per cent of the management and supervisory categories are allowed in the office limited to 4 hours only a day starting from 10.00 am until 2.00 pm for 3 days a week.
