	 Hand sanitizer is provided at the entrance and ensure of its use before entry.
	 The use of the MySejahtera application is mandatory in areas with wide internet access. The use of the customer attendance registration book is only allowed at areas without internet coverage or other reasonable grounds (senior citizens, the absence of smartphones etc.).
	 Licensees and premise owners ensure customers check in the premises using MySejahtera or manually write the name and phone no. in the absence of internet coverage.
	 It is mandatory for employers, workers, customers and visitors to check in with MySejahtera or to manually write down their names and telephone numbers legibly before entering the premises including at Government, private sector and individual offices.
	 For shopping malls, supermarkets or department stores, customers need to conduct a body temperature scan only once at the entrance of the complex and not at every business premise under one complex.
