Additional passengers are subject to PDRM approval based on case to case basis. • The number of persons allowed in the vehicle carrying goods as well as the chain of economic or industrial activities (except transportation of workers) depends on the vehicle registration license. • The number of people allowed in the Department Vehicle or the Official Car of the Post is based on the capacity of the vehicle. • Land public transport activities and services (trains, commuters, buses, taxis, e-hailing) allowed to operate as usual with 50% capacity. Number of passengers in taxi and e-hailing limited to two (2) people only including the driver. • Arrangements to carry out official Government duties are allowed with a letter of confirmation from the Head of Department or a valid employee pass subject to the current instructions of the Chief Secretary to the Government. The movement for legal matters is based on a letter issued by MITI (CIMS). • Permission to work for the private sector only for necessary services (essential services) only with a confirmation letter from the employer or a valid employee pass. • Employees of necessary services (essential services) and only authorized factories and business premises can use the approval letter of the Ministry or Department that has been issued previously.
