Yesterday, **29 July 2021**, Operation BENTENG (Op BENTENG) involving the Malaysian Armed Forces (ATM), PDRM, Malaysian Maritime Enforcement Agency (APMM), Malaysian Immigration Department (JIM), Royal Malaysian Customs Department (JKDM), Malaysian Border Control Agency (AKSEM) and other agencies have made arrests against 1 PATI person and confiscated 5 land vehicles.

## **H. BASIC ESSENTIAL GOODS**

Yesterday, 29 July 2021, the Ministry of Domestic Trade and Consumer Affairs (KPDNHEP) made 810 special daily monitors on 10 types of supply of basic necessities consisting of retailers (643), wholesalers (135), and manufacturers (32).

KPDNHEP has also conducted 1,848 special inspections and out of that number, all premises comply with SOPs.

Monitoring and inspection by KPDNHEP enforcement personnel at the retail and wholesaler level found that the food supply was stable and adequate.
