WHAT IS MYWiT?




It is an initiative to incentivize employers to hire unemployed Malaysians via digital re-skilling or upskilling.

The initiative also aims to meet the strong demand for digital business services jobs, and higher value digital tech jobs.

What does it offer?

Salary and training incentives for companies to hire digital talent.

ELIGIBILITY CRITERIA: FOR EMPLOYERS

Digital Business Services (DBS)

Max hiring: 500

Digital Tech Apprenticeship (DTA)

Max hiring: 50

1. Incorporation in Malaysia under the Companies Act 1965 or the Companies Act 2016
2. Minimum paid-up capital : RM20,000
3. Not be the subject of a liquidation/winding up/dormant
4. Not a public-sector employer, federal & states statutory body and local authority
5. Offering employment for a minimum of 12 months
6. Employment offer letter issued after online qualifying application date
7. Company director / shareholder / partner / senior management to declare and disclose if there is any close business relationship/close family relationship with any of MDEC's director or employee
8. Not a current recipients of any government/MDEC grants that include hiring and/or training subsidies.

ELIGIBILITY CRITERIA: FOR EMPLOYEES

- Fresh graduates, unemployed* & retrenched employees

Digital Tech Apprenticeship (DTA)

- Unemployed* & retrenched employees

1. Malaysian citizen
2. Must not be a close family member (spouse, parent, child (including adopted child or step-child), brother or sister, spouse of child, brother or sister) of a director/shareholder/top management of the hiring company
3. Not a current/past beneficiary of any MyDigitalWorkforce Work In Tech (MYWIT) incentive in any company
4. Not part of PenjanaKerjaya 2.0 and Penjana KPT-CAP programmes

*unemployed for min of 2 months

APPLICATION CHECKLIST

Digital Business Services (DBS)

Digital Tech Apprenticeship (DTA)

Stage 1 - Qualifying

1. Fully completed and signed online application form
2. Job posting link (an active link for minimum duration of 2 months)
3. For company operated >1 year - Verified Audited Account and as to date Management Account
4. For company operated <1 year - As to date Management Account

Stage 2 - Approval

1. Copy of employment offer letter for a minimum duration of 12 months;
2. Copy of new employee IC;
3. Copy of past 6 months EPF statement of the new employee
4. Retrenchment Letter (for retrenched employee)
5. Letter of commitment between Employer and Training Provider or Purchase Order (for Career Upgrade/Work & Learn Courses);
6. Quotation (only for Learning on Demand courses) ;
7. In house training details as per template provided (for DBS only)
8. Evidence of fund / project completion for any government funding (if applicable);
9. Central Credit Reference Information System (CCRIS) Report for top five major shareholder;
10. A Board of Directors' resolution (as per the template provided) of the applicant approving and authorizing, inter alia, execution of the Funding Agreement ;
11. Cover letter to confirm that all the documents and information submitted are correct and sign by the company authorized signatory.

SPECIFIC CONDITIONS

Digital Tech Apprenticeship (DTA)

1. Company can only submit one application until approval stage. Company may submit 2nd application after accepting MDEC's Letter of Offer for the first application and it is subject to fund availability.
2. The reimbursement of the incentive is only applicable for participant who has completed the first 3 months on the programme.
3. Employers are not allowed to replace a participant (hired employee) under the incentive
4. Employers are required to notify MDEC and provide documentary evidence within 30 days if the participant resigns, or if employers terminate the participant from the company
5. Employers are required to provide an employee status report at the end of 6 and 12 months employment together with latest EPF statement and any additional evidence to verify the salary payment transactions (if required) of the Participating Employee
