3. Complete Vaccination

Individuals who have been fully vaccinated are individuals who have met the following criteria:

- For vaccine types that require two doses of injection (such as Cormirnaty (Pfizer-BioNTech), COVID-19 AstraZeneca (Oxford-AstraZeneca), CoronaVac (Sinovac), Spikevax (Moderna) and Covilo (Sinopharm)), the individual must have passed the 14th day. -14 from the date of injection of the second dose; or
- For types of vaccines that require only one injection dose (such as COVID-19 Janssen (Johnson & Johnson) and Convidecia (CanSino)), the individual must have passed the 28th day from the date of injection.

Public Health Protocol	<ul style="list-style-type: none"> • Licensees and premises owners are required to provide the QR Code facility • MySejahtera and provide customer attendance registration book. • Hand sanitizer is provided at the entrance and its use is ensured before entering. • The use of the MySejahtera application is mandatory in the area of wide internet access. The use of customer attendance registration books is only allowed in areas where there is no internet coverage or other reasonable reasons (senior citizens, absence of smartphones etc.). • The licensee and the owner of the premises ensure that customers check in the premises using MySejahtera or manually write the name and no. phone if there is no internet coverage. • Employers, employees, customers and visitors are required to check in MySejahtera or write manually the name and phone number that can be read (if there is no internet coverage) before entering the premises, including in Government offices, private and private. • For shopping malls, supermarkets or department stores, customers only need to perform a body temperature scan once at the entrance of the complex and not at every business premises under one complex. • Body temperatures above 37.5 degrees Celsius are not allowed to enter the complex and premises. • The owners of complexes and premises outside the complex must ensure that only customers with "Low Risk" status including "Casual Contact Low Risk" in MySejahtera are allowed to enter their respective complexes or premises. • Licensees and premises owners ensure control of customer entry and exit to premises with physical distancing of at least 1 meter.

Citizens and Non -Citizens Returning/ Arriving from Abroad	<ul style="list-style-type: none"> • Citizen and non -citizen travelers who have a residence in Malaysia (including PR and Malaysia MY Second Home) who return or arrive from abroad and have been fully vaccinated, are allowed to undergo mandatory quarantine at home and are given a digital Home Surveillance and Observation Order (HSO) subject to the risk assessment of the Ministry of Health Malaysia (MOH) and details issued by the MOH. <ul style="list-style-type: none"> ➢ Shows evidence of RT PCR test report with negative result conducted 3 days before departure. ➢ Have a valid certificate of vaccination COVID-19 complete dose (depending on the type of vaccine). ➢ No symptoms during health screening at the National International Gateway (PMA). ➢ Have a suitable residence to carry out quarantine. • Individuals who return / arrive from abroad and have not been fully vaccinated or not vaccinated must undergo quarantine at a designated quarantine center and subject to the details issued by the Ministry of Health Malaysia (MOH). • The mandatory quarantine period for travelers from all countries is 14 days and can be extended for another 7 days if there is a need based on the results of the risk assessment conducted on the 14th day. • Travelers are required to make a daily self -assessment through Home Assessment Tool (HAT) in the MySejahtera app and this activity should continue until the end of the quarantine period (either 14 days or 21 days from the date of arrival). • Travelers are required to undergo the COVID-19 infection detection test screening i.e. the COVID-19 RT-PCR test upon arrival at PMA. A repeat screening test of the COVID-19, RT-PCR COVID-19 infection detection test was performed on the 10th or 18th day (for travelers who had to undergo quarantine for 21 days)
