MEDIA STATEMENT

YB TUAN HAJI AYUB BIN JAMIL JOHOR STATE EXECUTIVE COUNCIL (EXCO) MEMBER

PERMISSION FOR THE MANUFACTURING SECTOR TO OPERATE AT ALL LOCAL AUTHORITIES IN JOHOR

- 1. Based on Standard Operating Procedures (SOP) issued by the National Security Council (NSC) in force in the state of Johor throughout the National Recovery Plan (NRP) Phase 1 which is applicable starting August 20, 2021, and was updated on 3 September 2021, Manufacturing Sectors are ALLOWED TO OPERATE according to the employee's complete vaccination rate.
- 2. Therefore, the Johor Local Authority (LA) allows any industry sector involved in the Manufacturing Sector to operate throughout the state of Johor as mentioned in SOPs issued by NSC.
- 3. For information, there should not be any doubt to wait for permission to operate again after reaching the complete vaccination rate of 50 percent of the adult population in this state in view that as of September 3, 2021, 82% of the population in the state of Johor has received the first injection dose and 51.5% received their second dose.
- 4. The permitted operating capacity is as follows:
 - (a) 40% employees complete vaccination rate Allowed to operate with 60% employee capacity
 - (b) 60% employees complete vaccination rate Allowed to operate with 80% employee capacity
 - (c) 80% employees complete vaccination rate Allowed to operate with 100% employee capacity
- 5. Antigen RTK test should also be performed on employees every 2 weeks with costs borne by the employer.





- 6. It is also reminded that individuals who have been **completely vaccinated** are only those who have met the following criteria:
 - i. For vaccine types that require two doses of injection (Pfizer, AstraZeneca, and Sinovac), the individual in question must have passed the 14th day from the date of second dose injection; or
 - ii. For types of vaccines that require only one injection dose (Johnson & Johnson and CanSino), the individual must have passed the 28th day from the date of injection.
- 7. I would like to emphasize to employers and employees of the manufacturing sector to always comply with SOPs in the workplace and meet the requirements that have been set before resuming operations for the guaranteed safety of workers and the workplace.
- 8. I hope that this facility can revive the manufacturing and economic sectors in the state of Johor and further assist employers affected by the outbreak of COVID-19
